EXECUTIVE ORDER

Sub :- Compulsory certification on Public Procurement for Government employees under State Government

Whereas the Finance Department, Government of Assam, has developed an e-learning course on Public Procurement to strengthen the understanding of the Assam Public Procurement Act and Rules among State Government officials;

And whereas the Government of Assam has approved the proposal to make certification in Public Procurement mandatory for certain categories of Government employees, based on the recommendation of the Finance Department and the concurrence of the Administrative Reforms, Training, Pension and Public Grievances (ARTPPG) Department;

Now, therefore, in pursuance of the aforesaid approval and in public interest, the Government of Assam hereby directs the following:

1. All employees belonging to Group A, Group B and Group C services, as classified under the Assam Services (RoP) Rules, 2017, shall be required to obtain mandatory certification in Public Procurement through the e-learning course hosted at <https://assamprocurement.com/assamprocurement/>.
2. The said certification shall also be mandatory for all employees in the rank of Junior Administrative Assistant / Junior Assistant or equivalent and above, regardless of whether they fall under Group A, B, or C.
3. Completion of the certification course shall be treated as a pre-condition for promotion to higher posts within Group A, Group B and Group C services.
4. All Departments shall ensure that employees falling under the above categories obtain the certification within a period of six months from the date of issue of this Order or within six months of joining, whichever is later.
5. Any exemption or relaxation from this requirement shall be considered only with prior approval of the Personnel Department, in consultation with the Finance Department.

This Executive Order shall come into force with immediate effect.
