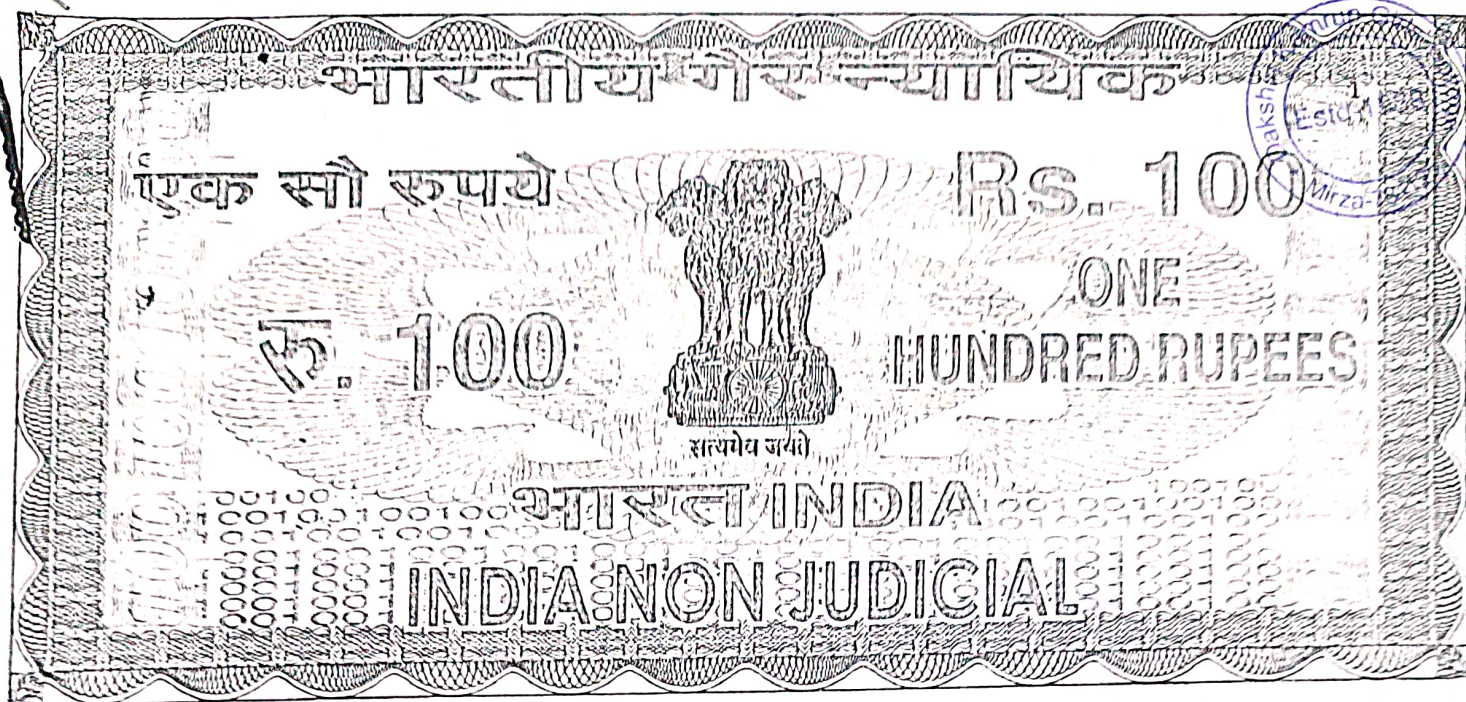

Whereas IPT is desirous to establish a Skill Training Center in Guwahati, Assam in the premise of the college for the purpose of undertaking skill development training activities with a motto to increase employability amongst the youths of the State And whereas the college is interested to start Skill Training Initiatives in the college premise and has earmarked separate premise (building) for the said purpose, for the betterment of the existing / ex-students of the college and the society at large free of cost for the students of the college.

IPT has approached the college for the establishment of a Skill Training Center in the premise of the college and 'College' appreciably agreed to the proposal and both the parties have thus agreed to enter into the following understanding.

1. IPT will offer the **ASSISTANT HAIR STYLIST TRADE** (BWS/Q0201) under Beauty & Wellness Sector of as per the guidelines of **National Skilled Development Corporation (NSDC)** under the **scheme Placement Linked Skilled Development Program (PLSDP)** as implemented by **Assam Skilled Development Mission (ASDM)** in the state of Assam.
2. The entire revenue and capital expenses will be borne by IPT to conduct the courses.
3. The College has earmarked the required infrastructure for the corresponding job role for undertaking skill development training activities within the said premise to IPT for the said purpose during the tenure of this agreement and its subsequent renewals.
4. IPT will, if required as per the job role, seek permission to use the necessary computer laboratory equipments for practical classes.
5. The College permits IPT to display their banner/hoarding/sign board in the said premise along with project specific displays.
6. The College permits IPT to arrange for necessary approvals of the Skill Training Center from concerned regulatory bodies like NSDC/SSC/ASDM etc. as and when required.

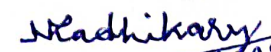


- 3) IPT will decide the courses, their duration and the curriculum.

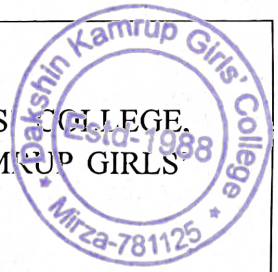

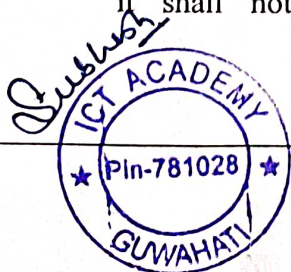

- 1.7. ICT Academy agrees to provide various domain specific training program to the teachers in the university and its colleges on regular basis.

3. Validity of this MOU

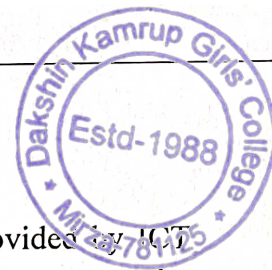

9. Commercial

10. Arbitration

In the event any of any claim, controversy, dispute or difference between the parties, arising out of or in connection with or in relation to this agreement either party will be entitled refer the same to arbitration in accordance with the rules of arbitrators, one to be appointed by ICT Academy, the other to be appointed by DAKSHIN KAMRUP GIRLS' COLLEGE, MIRZA, ASSAM, and the third to be appointed by the two arbitrators appointed by the parties. - 1.7. ICT Academy agrees to provide various domain specific training program to the teachers in the university and its colleges on regular basis.
- 1.8. ICT Academy shall bring industry certified trainers of the DAKSHIN KAMRUP GIRLS' COLLEGE, MIRZA, ASSAM, on every program conducted for the teachers/researchers of the college.
- 1.9. Both the parties shall explore and jointly develop new course for the teachers from time to time the terms for the same will be discussed as and when required

2. Operation of this MOU

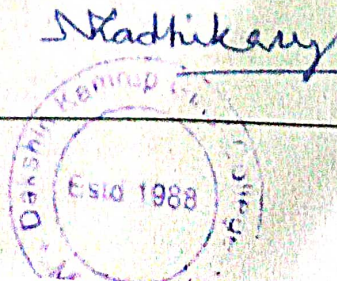
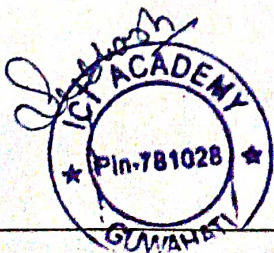
4. Confidentiality

10. Arbitration

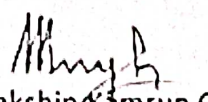
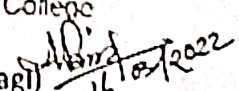
1. To share knowledge, information and resources for the benefit of the students and faculties.
