



Contents, training materials and such other information provided hereunder beyond the scope of this MOU and shall not share such information with any third party or render services utilizing the materials, contents, training materials to the third parties without the consent of ICT Academy except for academic activities.

- 1.7. ICT Academy agrees to provide various domain specific training program to theteachers in the university and its colleges on regular basis.
- 1.8. ICT Academy shall bring industry certified trainers of the DAKSHIN KAMRUP GIRLS' COLLEGE, MIRZA, ASSAM, on every program conducted for the teachers/researchers of the college.
- 1.9. Both the parties shall explore and jointly develop new course for the teachersfrom time to time the terms for the same will be discussed as and when required
- 1.10. Both the parties shall explore to work on specific ICT related research areas as perthe industry requirement and agreed upon by both the parties

2. Operation of this MOU

Upon execution of this MOU, ICT Academy shall communicate to DAKSHIN KAMRUP GIRLS' COLLEGE, MIRZA, ASSAM, the training schedules. Thereupon, the parties shall mutually discuss and agree on the operational terms based on which ICT Academy would offer its various other services.
