(2nd Party)

Wherein

Department of Assamese, Bimala Prasad Chaliha College, Nagarbera, Kamrup, Assam and Department of Assamese, Dakshin Kamrup Girls' College, Mirza mutually make a strong relationship for the exchange of knowledge and excellence. They have decided to apply their energies to academic excellence and research in language, literature, culture and the humanities.

The first party wishes to promote academic quality being one of the growing HEIs with the second party and agrees to establish academic cooperation in the areas of mutual interest in accordance with the terms and conditions set forth in this Memorandum of Understanding (MoU)

Objectives: The objective is to facilitate collaboration between the two institutions, provide opportunity for students and faculty in the areas of learning and research and to promote knowledge on the basis of mutual benefit, good initiatives, and frequent interactions.

The First Party and the Second Party agree on the following terms:

- (a) To jointly organize seminars, conferences, workshops on topics of common interests for the benefit of the faculty members.
- (b) To jointly undertake research and training programmes and to invite each other's faculty to participate in them.
- (c) To exchange faculty members and students for the purpose of academic excellence.
- (d) To exchange information pertaining to teaching, learning resources, extension activities etc.

Tenure and termination:

This MoU will be effective from the date it is signed by the representatives of the two institutions. It will remain valid for **03** (Three) years and may be continued thereafter with joint consideration and agreement.

Coordination: Each institution shall appoint one member from its teaching faculty to coordinate the programme on its behalf. Moreover, a committee consisting of the following members will periodically review and find out ways to strengthen cooperation between the two institutions.

- (c) Head, Department of Assamese, B. P. Chaliha College
- (d) Head, Department of Assamese, D. K. Girls' College
- (e) Coordinator, I.Q.A.C., B. P. Chaliha College
- (f) Coordinator, I.Q.A.C., D. K. Girls' College

Arbitration: In case of any dispute relating to any aspect of collaboration under this MoU, the Principal, B. P. Chaliha College and the Principal, D. K. Girls' College will jointly resolve the dispute in a spirit of mutual respect and shared responsibility.
