NOW THIS MEMORANDUM OF UNDERSTANDING (MoU) WITNESSETH AS FOLLOWS:

1. To share knowledge, information and resources whatever it may be for the benefit of the students and faculties.
2. To undertake students' exchange/competition programmes at their free will.
3. To undertake faculty exchange/participation programmes at their free will.
4. To undertake publication works in collaborative mode between the faculty members/students of both the institutions.
5. To introduce certificate courses designed by the faculty members for the benefit of the students. These courses will be governed under the guidelines provided by AICTE, HRD etc. as per requirement.
6. To organize educational field trips and conduct surveys to sensitize students about cross cutting issues. These activities will be strictly under the supervision of the Head of the departments.
7. To organize students' seminars with mutual support.
8. To organize workshops for students' benefit.
9. To organize national seminars with mutual support.
10. To utilize the library resources of both the colleges by the students and faculty members.

11. The students will be made to comply with the policies of both the colleges.
12. The MoU will be valid for a period of 5 years.
13. The MoU will not be legally binding to either side.
14. **Termination:** Either party may terminate this MoU by providing written termination notice of its intension to terminate the MoU to the other party.
